# Village of South Glens Falls Comprehensive Plan Community Survey Results February 2008

### Introduction

To provide an additional opportunity for residents and property owners to contribute to the comprehensive planning process, in mid January 2008, the Village of South Glens Falls conducted a Public Opinion Survey. The survey was accessible online at the Village website between January 22, 2008 and February 4. 2008. Postcards with log-in information and instructions for obtaining paper copies of the survey, were mailed to all property owners prior to the survey opening date. In addition, an advertisement regarding the survey was placed in the Post Star in order to reach other residents of the Village and paper copies were hand-delivered to the Mid-town apartment complex, to reach senior citizens who may not have received the post card. Paper copies of the survey were also available at the Village Clerk's office to accommodate individuals who do not have access to the Internet.

The survey included 21 multiple-choice questions and an open-ended comment area at the end. The intent of the survey was to gauge public opinion about quality of life and municipal services, as well as specific issues and areas that the Village should change or improve in the future. The results of the survey will help the Village define future planning goals, objectives, and strategies for the updated Comprehensive Plan, that will guide future decision-making related to community improvements for main street, housing, municipal services, public infrastructure, and overall economic development efforts.

One hundred fifty eight (158) surveys were completed, resulting in a response rate of 12.9%. Survey respondents included a range of age groups, but a larger percentage of females than males. Of the total respondents to the survey, only 4.3% were below the age of 34 and approximately 30% were 65 and over. **Responses to the survey are tabulated below:**

1	The Village is being maintained efficiently and will address several issues which will improve most situations as they occur.
	Property taxes and the increases of all service are going to drive retired people out of New York State. We need more commercial activity to offset the tax base.
3	I think that the Village of South Glens Falls needs to develop it's commercial base to attract industry that will help to support the community from a fiscal standpoint. Other Villages should be examined for best practice and we should be replicating what these Villages have successfully done to insure the community continues to grow and not stagnate. The Village of Ballston Spa is a good example of such a Village. I applaud the efforts of the Villages leaders in surveying the community in an effort to improve. Change is a process, not an event and it will take time, but you are headed in the right direction! Great Job!

4	We have lived here too short a time to have informed responses to some questions. However, the small town flavor is a plus, and any planning that keeps services and businesses somewhat centralized seems like a good idea, especially from an environmental, energy efficiency point of view. Well-maintained and upgraded infrastructure should go without saying, as should a greater emphasis on design standards that promote attractive and compatible buildings, commercial businesses and landscaping. The main corridors could use a face-life. Just how this is accomplished, I would leave to those who do urban planning. This is a fine
5	community, and we hope that it can retain its character with judicial planning. More senior housing needed within the village so people can easily get to stores, the post office, church, etc. The Moreau Community Center should be for Moreau as the town is growing very rapidly. Also it could be scaled back to make it more affordable. See if some activities could be available at the schools for youth and adults such as basketball courts, etc. and at night. In other words, provide for activities which can't be pursued anywhere else in the community at this time. Code enforcement is very lax and must be stepped up.
6	I don't think there are enough high-paying jobs around here to support the new community center.
7	I would suggest an arrow be added to the traffic light at the intersection of Saratoga Ave and Feeder Dam Rd.
8	The Department of Public Works crew is excellent, courteous and reliable. I can't tell you how impressed I am with you, especially when compared with DPW crews in surrounding communities. We are very lucky. I am also very supportive of the Moreau Emergency Squad and the SGF Fire Departments, and think the Village should do everything they can to support those organizations. As to the Moreau Community Center, I think Doug Taylor should resign and I think they need to rethink the proposed Regional Community Center. The current design is not financially feasible. Thank you for the opportunity to take this survey, and for notifying residents by mail. This is excellent, and what I look for in a local government! Congratulations!!
9	We are very happy to live in South Glens Falls. We enjoy our walks within the Village and along the Hudson River. We support our schools, especially during the annual Marathon Dance. It would be nice to have a better selection of stores to shop at and places to eat. The building of the Community Center warrants higher priority in development of our Village. If funds are not available for this project, then we should work with our Schools to supply the facility. Put the dollars to use that would enhance the schools and the community. One note of concern is the lack of an enforceable ordnance against burning. It is bad during the Winter months, but much worst in the Summer when windows are opened. If you have breathing difficulties, this forces you inside.

I realize the property taxes are needed, but it IS hazardous to try and pull out of theretraffic needs attentionAnd that bldg made it worse! I think landlords should keep their property up, as I keep my property up and am amazed how many people leave their property w/o any TLCI realize that most people are not as much of a gardener as I am, but some property is a real eye-sore.

29	Many questions should have been separated into two parts. It was hard to always give a fair answer. I am concerned about allowing too many low-income housing developments in as this increases the strain on our schools and thus our taxes. We need to also make sure that all new businesses adhere to a presentable property design as opposed to allowing them to be garish in color and design. We should definitely have higher standards when it comes to this. And we should then follow through, by enforcing the standards. (The owner of the new apartment complex off of Hamilton St. should be made to take care of his original investment as well as construct new. Otherwise, the new will deteriorate as well.) Traffic is going to be problem on rte. 9. I am in favor of the Community Center as long as it is going to be financial sound. I'm not sure that there are enough checks and balances involved with this project. I don't want to have to pay for this using my taxes. 32	Overall, I am very happy living in SGF. I think this is a great village with people that really care about their homes, their community, and their neighbors. We are lucky to have a low crime rate, good facilities, and relatively low taxes. The Village normally does a great job in most areas. However, I would like to suggest that the section of road - from Main St (Route 9/32) at the traffic light at intersection of Hudson St. (near the flower shop and McDonalds and Stewarts Shop) down to the light before the Bridge over the Hudson River - be repaved especially on the side in front of the Midtown Shopping Plaza. This entire section has fallen into disrepair and is really getting rough on cars. As one of many people that have to commute over that same stretch of road every day, I would like to see this taken care of. I'm sure there may be other roads that need to be addressed, but given that Main St. sees so much commuter traffic every day, this really needs to be fixed soon before it leads to damage of people's cars. I am happy to see that the manholes on Rte 9/Saratoga Ave were repaved/repaired over the last several months. This had become a huge problem and I'm glad the Village fixed this. In terms of economic development, it would be good to try attracting some other businesses to setup shop here in SGF and it would be good if these businesses were something other than gas stations which we have plenty of. We are extremely fortunate to finally have the Hannaford store here, which we desperately needed for far too long. Maybe there is a way to draw other establishments to our village that would normally co-locate with Hannaford stores. Also, there are many financial and accounting firms that currently reside in Glens Falls and Queensbury where the taxes are significantly higher. Couldn't we try to attract similar types of businesses to setup shop here in SGF? Are there currently existing commercial properties within the village that are lying fallow or in need of renovations

	that we could use to draw new businesses to our village rather than creating new construction for this purpose? I believe in cleaning up what we've already got rather than converting and developing our green spaces.
33	Watching Glens Falls become revitalized is somewhat depressing as a SGF resident. There is so much potential. SGF needs an identity - why should anyone go to SGF when they can pass through to get to GF or Saratoga? Communication about what is going on in the area seems limited if residents do not get the Post Star. I don't see people in the neighborhood as very friendly compared to other neighborhoods I have lived in. I'd love to see the Moreau Community Center serving local needs (Warren and Washington county have their own needs) that would include more than pre- school and senior citizens. I like SGF, but I find I spend very little time there because there is little for my family to do. I hope to see SGF improve, but since I have lived in the area, it seems like it has been frozen in time while other areas are thriving.
34	Anything done to prevent our community from being overrun by the metropolitan sprawl from our south will be a tremendous plus for South Glens Falls.
35	The largest problem facing small business owners is the possibility for future tax increases. Any and all tax increases result in decrease in employment and a rise in prices resulting in less money for the average consumer all around. Any responsible city government will try to cut taxes to spur economic growth during these troubled times.
36	The Betar Byway is about the only safe area to walk in the village. But I do not feel I should have to drive to it. A good share of the sidewalks in the Village are in bad shape and need replacing. Example #1 Hudson street side of TD Banknorth. #2 Front of I89 Main Street. Sidewalks not cleared of snow and ice in the winter. Blocking sidewalks off completely all winter when plowing snow. Example Front of 152 Main Street. Another dangerous situation is the parking of boats and RV Trailers in Village Streets all Summer and Fall. Example Drive down Prospect and Washburn Streets. Another situations not enforcing crossing the highway at the designated crosswalks. Example: Try crossing in front of St. Michaels church before the Saturday 4:00 PM mass. Even a SGF police zoomed right by.
37	It would be nice to have SGF with some kind of a big name/dept store. Something other than "dollar" stores. If you need something you either have to travel to Wilton or Queensbury. Wouldn't the revenue be good for our town? Another comment is that I would like to make is I do not agree that you should "strictly" enforce properties to be kept up, but maybe put a little pressure on the people that have yards full of "junk" or trailers or dead vehicles in front/backyards.
