Mayor Orlow stated that there was a new budget handed out by <u>Trustee Girard</u> this morning. He would like to make a statement before they Board proceeds with the workshop on the budget. He wanted to extend his heartfelt apologies to Clerk-Treasurer Dannae Bock and her family for the criticism because she was not wrong (as stated in the Post Star). The way she was chastised was unjustified. If the Board had listened to her years ago, the Village wouldn't be in the situation that it is in today. She is one of the most capable people. She was at no way at fault for this situation. In fact she is a model for most municipalities for the way their clerk-treasurers should be.

Mayor Orlow said that the Board has asked the unions to work with them. Things have been difficult for the employees recently. The unions have been made out to be the "bad guys" lately and they are not. They provide the residents a service. Many residents have commended the DPW and Police Department. The Village employees are one reason many people want to live here. The other day a Village resident who lives in Pruyn Crest wanted a new road put in. The DPW needs new equipment and also the money to provide such services. Please consider that when considering the budget changes.

The Mayor opened up the meeting to the workshop to work on the budget at this point.

Attorney Muller stated he will guide the Village Board in areas that the Village needs to be very cautious about. Attorney Muller stated that the Board cannot cut a mandate i.e. union contract items.

Attorney Muller read the changes to the budget (listed above) from the original tentative budget.

The total expenses are now \$2,609,067.00. The total saved is \$105,478.00.

<u>Trustee LaFave</u> stated that the way the Board room is set up is not conducive to conversation among the Board members. Mayor Orlow stated the set up may need to be changed again.

<u>Trustee Carota</u> asked about how they calculate the appropriated fund balance. There was some discussion how this was determined and what it would be in the new budget. <u>Trustee Carota</u> will contact Clerk-Treasurer Dannae Bock to try to figure out the appropriated fund balance to then calculate the tax rate.

At 9:00pm the Mayor closed the workshop. He then opened the regular meeting.

The Mayor asked for a motion to adopt. Attorney Muller stated that there were individual resolutions made for each line item. He recommended that a resolution be made to accept all the changes made tonight in the workshop. <u>Trustee Carota</u> so moved to accept the changes and <u>Trustee Hayes</u> seconded. <u>Trustee LaFave</u> agreed and the motion passed.

The revenue was changed in the following accounts.

A2665 (Projected Police Car sale) was changed to \$2500 by motion made by <u>Trustee Carota</u> and seconded by <u>Trustee LaFave</u>. <u>Trustee Hayes</u> also approved and the motion passed.

The total revenue is now \$1,122,749.

<u>Trustee Carota</u> moved to adjourn this meeting and reconvene the meeting at 5:30 pm on Friday, if not before, to approve the budget after calculating the appropriated fund balance and tax rate. <u>Trustee LaFave</u> seconded and the Board unanimously approved.
